Funds Raised through Options Exercise

Estrella Resources Ltd (**ASX:ESR**) ('**Estrella**' or '**the Company**') advises that Jason Peterson, major shareholder and head of corporate of CPS Capital Group has exercised 20,000,000 listed options exercisable at \$0.02 (ASX: ESROA) to raise \$400,000. Funds raised from the option exercise will allow for expansion of drilling activities at the Company's Carr Boyd Nickel Project without the need to raise funds through capital markets. The Company recently announced a new nickel sulphide discovery at its flagship project in Western Australia (See ASX release dated 8 October 2020 "Significant Massive Nickel Sulphide Discovery Carr Boyd").

The Company has received other offers to exercise options from other major shareholders of the Company to finance its activities. Further announcements will be made in due course.

Jason Peterson says "I look forward to continue to support Estrella's activities to unlock a world-class discovery at Carr Boyd Rocks. I congratulate the Estrella team on their results to date and I look forward in assisting the Company further as its progresses".
